- 2) Using the received Reference No. download the "Anti-ragging affidavit by the student & Undertaking by Parent / Guardian"
- Take a printout of the mail & Affidavits (In the case of the hosteller kindly take two prints of downloaded affidavits to submit the same at the hostel).
- 4) Kindly put your signature on the Anti ragging Affidavit by the student and On the Undertaking by Parent / Guardian get your parent's signature.
- 5) Submit the mail received from anti-ragging cell, and duly signed downloaded affidavits at Window No. 21 Registrar's Office & in the hostel also (in the case of the hosteller)

The above action is required to be completed by 30.11.2022 by all the students of ABES - Existing students if yet not submitted and the newly admitted students during induction.
